## BACKGROUND

The Department has amended the following Duty Manual sections to update the procedures to complete DUI investigations.

# ANALYSIS

The Duty Manual has been revised to reflect changes described below. Additions are shown in *italics and underlined*. Deletions are shown in strike through form.

## R 1558 DRIVER UNDER THE INFLUENCE: (FORM CHP-202) (COUNTY FORM 909 A): Revised 03-10-22

This form is used to report the facts and circumstances surrounding an incident involving a<u>n</u> <u>impaired</u> drinking driver; to indicate that the person involved was admonished of <u>their</u> his/her rights; and to report when a<u>n</u> <u>impaired</u> drinking driver refuses to submit to a chemical analysis of such person's blood, breath or urine.

### R 1559 ADMIN PER SE (FORM DS367) (FORM DS 360):

Revised 03-10-22

<u>This form is u</u>sed for all DUI drivers (unless under age 21). <u>It is i</u>ssued in all cases regardless of the status of the driver's license status (suspended or never acquired a CDL). <u>Must issue <u>The</u> driver's copy <u>must be issued</u> at <u>the time</u> of arrest/processing to begin the DMV suspension action on that case. In those cases where the driver has never had a license, <u>the</u> DMV will assign an X-number and initiate the suspension order.</u>

### R 1560 ADMIN PER SE (FORM DS367M) (FORM DS 360A):

Revised 03-10-22

<u>This form is u</u>sed in place of the above form for <u>all DUI</u> drivers under the age of 21 with a BAC of .01 or greater. Above <u>This</u> forms <u>is</u>are NOT interchangeable <u>with Form</u> <u>DS367</u>.

#### R 1561 OFFICER'S STATEMENT (FORM DMV DS 367): Deleted 03-10-22

This form will be filled out by officers in all arrests when the suspect has been arrested for driving under the influence of alcohol or alcohol and drugs.

OFFICERS STATEMENT (DMV 367M): This form is similar to the DS 367 and is used when the violator is under 21 years of age.
