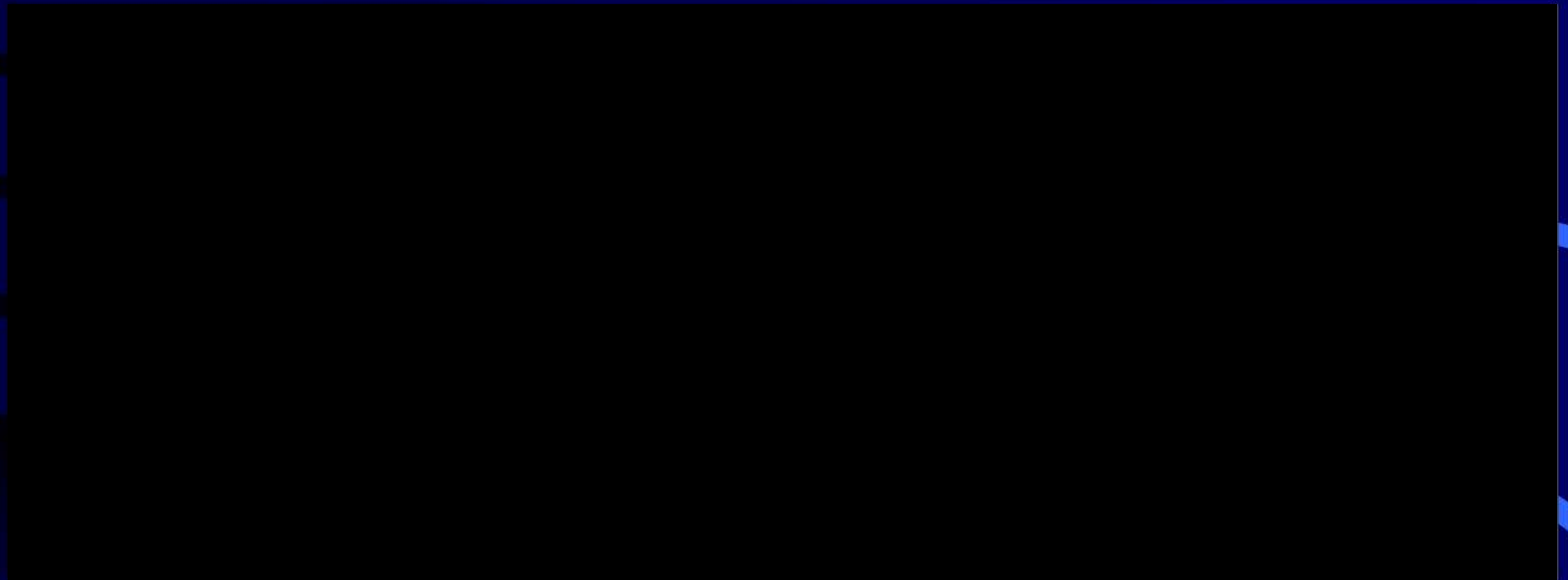

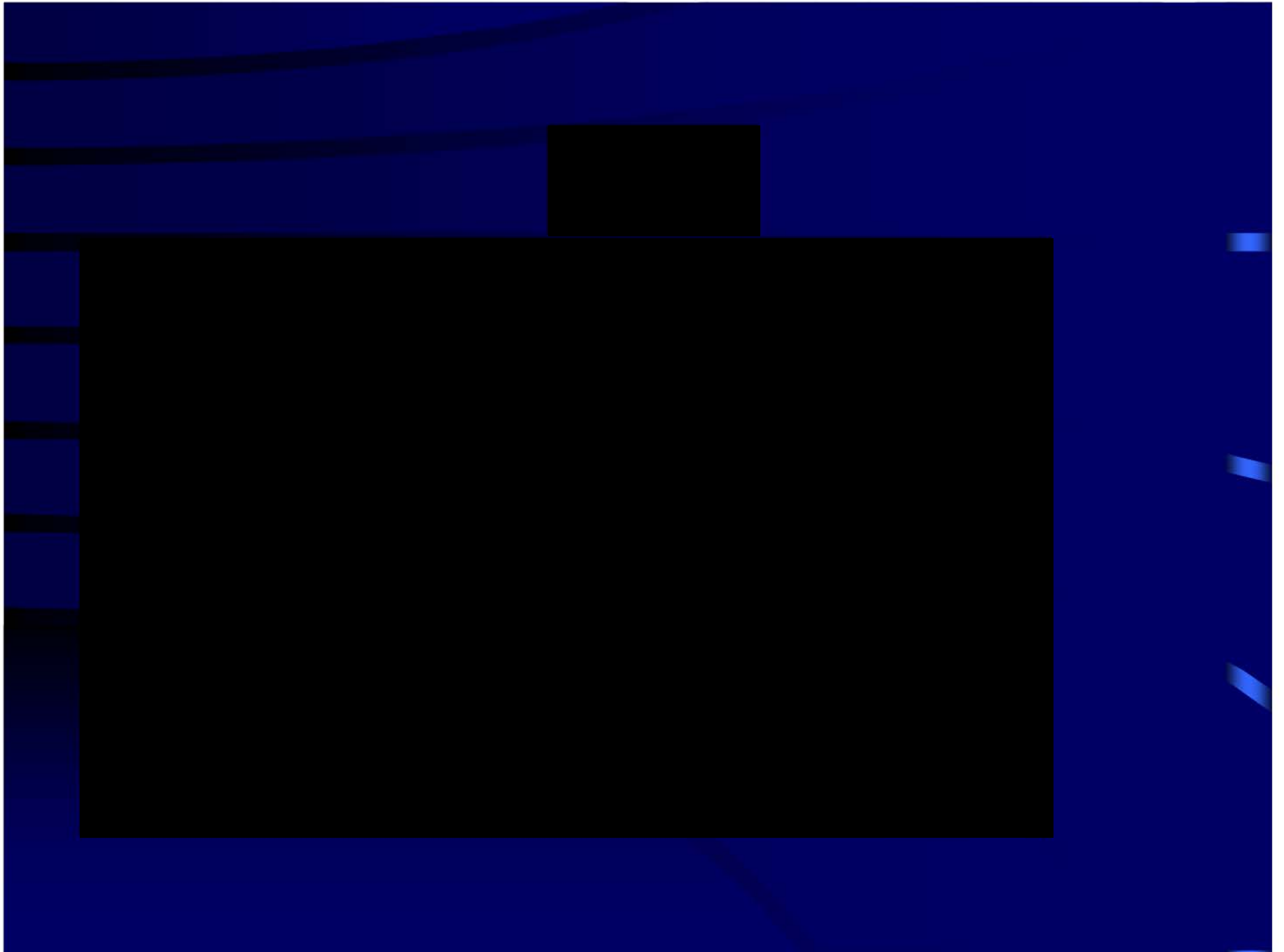

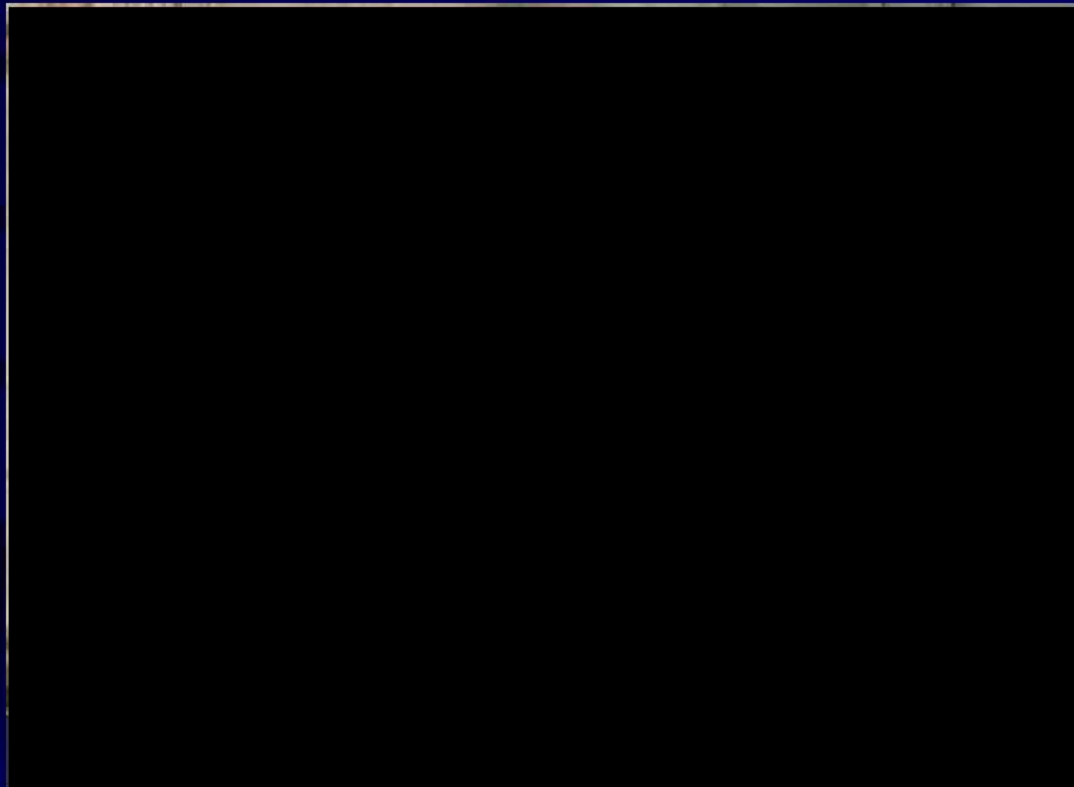

- PERSON DID SOMETHING TO ATTEMPT TO KILL THEMSELVES. METHODS CAN BE BY PILLS, WRIST SLASH, OTHER CUTTING, PISTOL, SHOTGUN, HANGING, OVERDOSE OF MEDS, ASPHYXIATION OR CARBON MONOXIDE, ETC

- **USUALLY HEARD BY CALLER "I HEARD A LOUD POP. I THINK IT WAS A GUN"**

GARBAGE COMPLAINT

- **USUALLY HANDLED BY CODE ENFORCEMENT.**
- **WE WOULD GO IF IN PROGRESS, ON WEEKENDS OR HOLIDAY OR AFTER HOURS WITH SGT APPROVAL.**
