Santa Clara County Child Abduction Protocol

CHILD ABDUCTION PROTOCOL

In the fall of 1999, a committee was established to revise the Santa Clara County Child Abduction Protocol and develop a countywide resource document. In January of 2000, the County Chiefs approved this protocol and resource document. Revisions to the protocol were made in June of 2002, March of 2004, and July of 2007. The following revision was made in October of 2008.

MISSION STATEMENT

Santa Clara County Law Enforcement Agencies and the District Attorney's Office are committed to thorough and effective investigation of incidents of child abduction. This commitment recognizes the importance of respecting victimized children and their families, holding offenders responsible for their conduct, and working as a team to solve cases of child abduction.

This protocol commits the signatory agencies to: 1) conduct thorough investigations of child abduction; 2) commit personnel and resources as available to assist the primary agency; 3) train its employees; and 4) contribute to the review of this protocol every three years.

INTER-AGENCY CHILD ABDUCTION PROTOCOL

"There is no more urgent crisis that faces investigators than the abduction of a child and the inherent threat to the child's life. The predators who stalk our children are much more transient, more sophisticated, and in many cases, more brutal than in the past. They prey upon the most naïve and innocent of our society without the regard to gender, age, race, or jurisdictional boundary. Their success at avoiding detection and prosecution seems only to fuel their seemingly insatiable lust to victimize others." *FBI Child Abduction Response Plan*

In these most critical of crimes involving innocent children, time is often another adversary. These complicated investigations can be very labor intensive, requiring a large number of investigators. Law enforcement must respond together, in the spirit of cooperation, and utilize our combined resources to investigate and solve these cases. The law enforcement agencies in Santa Clara County are committed to channeling all available resources to work together in partnership with state and federal agencies in response to a child abduction or suspected child abduction.

Each agency involved in this protocol agrees upon request and when available to provide investigative assistance and equipment as described below to any agency in the protocol to assist with a child abduction or suspected child abduction. The requesting agency(s) having jurisdiction over the crime will coordinate and supervise the investigative response.

A. Request for inter-agency assistance

- 1. Agencies may request assistance under this protocol under the following circumstances:
 - a. Any non-family child abduction, suspected child abduction, or when a child is missing under suspicious circumstances.
 - b. Child homicides that appear to be associated with abduction.

B. Activation

- Request for assistance should be made by telephone to the agency communications center. The request should include the request for assistance, the nature of the incident, the location where officers should respond and a call back number of the person requesting the assistance. A teletype request from the requesting agency should follow the telephone call.
- 2. Agencies should confirm their response as soon as possible indicating the number of officers and the anticipated time of arrival.

C. Inter-agency assistance

Each agency involved in this agreement will provide the following number of officers for an immediate response during the first 72 hours and a reduced number of officers for long-term investigative assistance. The long-term commitment could last as long as two or three months. If possible, agencies should send officers with training and/or experience in investigating child abductions, missing persons, crimes against children or homicides.

D. Special Conditions for activation of the inter-agency child abduction protocol

- 1. The agency(s) requesting assistance under the protocol shall supervise and coordinate all aspects of the investigation occurring in their jurisdictions, including personnel responding from other jurisdictions.
- 2. Agencies shall only request assistance under this protocol after approval of the Chief of Police or their designee from the requesting agency.
- 3. While each request for assistance dictates its own special procedures, it can be generally anticipated that officers responding under this agreement will work a maximum of 12-hour shifts. The requesting agency shall schedule personnel ensuring that they are properly relieved whenever possible.
- 4. This protocol is intended to provide inter-agency assistance with staffing and equipment, and is not considered mutual aid. Agencies supplying personnel and equipment for these incidents incur full costs for their personnel and equipment.
- 5. Agencies providing personnel will be responsible for providing their own vehicles, radios, flashlights and cell phones for their personnel.
- 6. It is understood that each agency's first responsibility is to insure service within its own jurisdiction. Therefore, agencies experiencing extreme staffing shortages in their own jurisdiction may find it necessary to modify their commitment to an agency's request.

E. Special considerations

- Agency's activating this protocol should anticipate other logistical issues including but not limited to: adopting a plan to manage the investigation, designating an area where investigators can work, coordinating radio communications and providing cellular telephone communications. Agencies are encouraged to address these and other issues prior to any activation of the protocol.
- 2. Commencing January 1, 2000, Section 49068.6 is added to the Education Code which requires law enforcement agencies to inform the school district, other local educational agency, or private school, in which the child is enrolled, that the child is missing. The notice shall be in writing, shall include a photograph of the child if available and shall be given within 10 days of the child's disappearance. The school shall then place the written notice on the front of the missing child's school record.

F. Alert Systems


There are now several ways to notify law enforcement, media, and the public of a child abduction. It is important to note that the criteria for the request for inter-agency assistance in Santa Clara County via the California Child Safety Amber Network will follow the guidelines established in Section A. 1. of this protocol. Great care should be taken to verify the abduction or to rule out alternative explanations for the disappearance of a child. Sufficient information should be available to disseminate to the public that could assist in locating the child, i.e., suspect and/or vehicle description, victim description, direction of travel. SCCO agencies have the option, and are encouraged to fill out the Amber Network checklist (attached to this protocol) and notify the CHP Emergency Notification Tactical Alert Center (ENTAC) at 916-657-8287 to assist with notification via TRAK, EDIS, EAS, local or statewide Changeable Message Signs (CMS) and/or the CHP website. The ENTAC telephone number is NOT to be disseminated to the public or the media.

SCCO agencies may, at their discretion, utilize the Amber Network for a family abduction if there is a compelling reason to believe the child(ren) may be in imminent danger of serious bodily injury or death.
