SUBJECT: 30-DAY IMPOUNDS PURSUANT TO

VEHICLE CODE SECTION 14602.6

On August 27, 2017, the Department issued Memorandum #2017-030 regarding Duty Manual Revisions: Towing Procedures (Intranet Link). On April 23, 2020, the Department issued Training Bulletin #2020-007 regarding the Impound Authorities Card (Intranet link). When comparing these two documents, they are in conflict.

The order in Memorandum #2017-030 states in part:

Effective immediately, Department members shall no longer use CVC 14602.6(a)(1) to place 30-day impounds on vehicles; instead, when the impound of a vehicle can be justified by an exigency under the community caretaking doctrine, Department members shall use either CVC 22651(p), to tow a vehicle driven by a person who does not have a valid driver's license (or for the other violations stated in subdivision (p)), or CVC 22651(h), to tow a vehicle when the driver is arrested.

However, the *Impound Authorities* card revised in Training Bulletin #2020-007 included the option for 14602.6 VC. The order from Memorandum #2017-030 still stands. Department members shall not use 14602.6 VC to place a 30-day impound on a vehicle.

The *Impound Authorities* card is being revised. Until a new version is available at Central Supply, Department members should cross out 14602.6 under 30 DAY HOLDS on the back of the card.
