SUBJECT: REVISED GUN VIOLENCE

EMERGENCY PROTECTIVE ORDER (GVRO) FORM EPO-002 **DATE:** January 20, 2023

Bulletin# 2023-003

On January 1, 2023, the Judicial Council of California adopted a revised version of the *Gun Violence Emergency Protective Order* (GVRO Form EPO-002). The language of the form has been updated to provide clear instructions on prohibited possession of firearms and parts of firearms by the restrained party.

The following changes were made to the revised form:

- The gender classification of "Nonbinary" was added to section 1.
- The language in section 2 was changed to include the prohibited possession of firearm parts: "If you have any firearms (guns), firearm parts (any receiver, frame, or unfinished receiver or frame as defined in Penal Code section 16531), ammunition, or magazines you MUST IMMEDIATELY SURRENDER (GIVE) THEM if asked by a police officer."
- The following language was added to section 4, advising restrained parties that they can attend the court hearing remotely: "You may attend the hearing remotely (check your court's website for instructions).
- The following language was added to section 8: "Firearms (including parts)."

All Department members should discard any previous versions of the GVRO Form EPO-002 and replace them with the new version of GVRO Form EPO-002 (Rev. January 1, 2023). The revised GVRO Form EPO-002 is available at Central Supply.
