SUBJECT: NEW TRAFFIC / NONTRAFFIC NOTICE TO APPEAR CITATION

DATE: March 22, 2024

<u>California Asembly Bill 2773 (AB 2773)</u> went into effect January 1, 2024, as Vehicle Code section 2806.5, which requires a peace officer making a traffic or pedestrian stop to state the reason for the stop before asking any questions related to a criminal investigation or traffic violation, unless the officer reasonably believes that withoholding the reason for the stop is necessary to protect life or property from imminent threat. The new statute also requires the officer to document the reason for the stop on any citation or police report resulting from the stop. See <u>Duty Manual Revision Memo</u> <u>#2024-006</u> for the new Department policy on stating the purpose for a traffic or pedestrian stop.

As a result of AB 2773, a new Traffic/Nontraffic Notice to Appear (TR-130) has been printed and distributed to Central Supply to comply with the new requirements necessary of a peace officer. The old TR-130 (updated 05/17) will no longer be accepted by the Santa Clara County Superior Court after March 31, 2024. The Department currently has the new TR-130 available for pick up at Central Supply. Department members should return their old citation books and request the new TR-130 as a back-up to the E-Cite.

Department members are reminded to "SYNC" your E-cite to download the latest electronic citation software prior to use. Once the "SYNC" is completed, the E-Cite will be compliant with AB 2773 and California Vehicle Code section 2806.5, which states officers are required to provide the reason for the vehicle or pedestrian stop on any citation and to document the reason for any citation or police report resulting from the stop. When completing the TR-130, Department Members should include a specific vehicle code violation and not write, "See General Offense Report or See G.O." Not including a specific criminal or traffic violation will cause a citation to be rejected or "kicked back" and may be used for the basis of filing a Motion to Supress hearing in court.

As a reminder, <u>Duty Manual Revision Memorandum #2022-030</u> went into effect July 1, 2022. All Department members except Reserve Officers are required to use the Department electronic citation system (E-cite) when issuing a Traffic/Non Traffic Notice to Appear citation. Paper citations are only to be used in instances of E-Cite connectivity issues or by Reserve Officers. Department members should refer to the following Duty Manual sections regarding additional information about issuing TR-130 citations:

L 2406 - Vehicle and Pedestrian Stops

The E-Cite system currently allows Department members to issue multiple violations on a citation and will automatically print a Continuation of Notice to Appear form if more than four violations are cited. Department members having problems connecting to the E-Cite system, using the new paper TR-130, and citing a subject for more than four violations will be required to complete a Continuation of Notice to Appear / Complaint (TR-108).

Court Times

Department members are reminded to reference the Department issued <u>2024 Citation and Warrant</u> <u>Citation Reference Guide</u> for additional information about citations, court dates, and times. Department members are reminded to fill in the appropriate appearance time for citations and should remember the following:

Effectively immediately, all Department members should obtain the new TR-130 booklets from Central Supply as a back-up citation and turn-in their old TR-130 paper citations for destruction.
